LIMITED REVIEW REPORT

1. We have reviewed the accompanying Statement of Unaudited Financial Results of TCFC Finance Limited ("the company") for the quarter and nine months ended June 30, 2017 ("the Statement") attached herewith, being submitted by the Company pursuant to the requirement of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, read with SEBI Circular No. CIR/CFD/FAC/62/2016 dated July 5, 2016.
